**From the West:** Take I-84 East. Just past Waterbury, take the Exit for I-691 East. From 691 take Exit 11 on I-91 North in Meriden. Continue on I-91 North to Exit 23 (West Street-Rocky Hill). At the end of the ramp, turn right. Hotel driveway is on right.

**From the East:** Take I-84 West. Just before Downtown take the Exit for I-91 South. Continue on I-91 South to Exit 23 (West Street-Rocky Hill). At the end of the ramp, make a left. At the second light turn right. Hotel driveway is on your right.
