#### Firm Hosts In Community Panels on Issues Facing Our Workforce and Community

In 2017, Shipman & Goodwin hosted three panel presentations as part of its "In Community" series. The first, held on June 28, was entitled, "Refugees and Resettlement: The Process and Protection Under the Law". Set amidst the growing and heated debate over the country's immigration policies in the aftermath of the 2016 presidential election and the ensuing presidential executive orders tightening those policies, panelists shared their insights on the selection and vetting processes, the role of local agencies in the resettlement process, and the impact of such executive orders. They also discussed the legal status and rights of refugees in Connecticut and the potential for community involvement going forward. The panel featured: Chris George, Executive Director of Integrated Refugee & Immigrant Services (IRIS); Kimberly May-Bailey, MSM, Director of

the Migration, Refugee and Immigration Services at Catholic Charities, Archdiocese of Hartford; and Jama Ahmed, Assistant Director of the Migration, Refugee and Immigration Services at Catholic Charities, Archdiocese of Hartford. Partner **Brenda Eckert** moderated the panel.

Co-sponsored with the George W. Crawford Black Bar Association, the Firm hosted "A Jury of One's Peers: A CLE Panel Discussion on Jury Diversity" on September 27. Panelists discussed the right to an impartial jury under the Sixth Amendment, with a focus on the importance and impact of diversity in the jury selection process in state and federal courts. Panelists also provided examples of Batson and hardship challenges, and jury behavior research to discuss how the lack of jury diversity affects the perception of justice within the community. The panel featured: The Honorable Victor A. Bolden, United States District Judge for the District of Connecticut; Allison M. Near, a partner and litigator at Sheehan, Reeve & Near, LLC; Edward

On November 15, the Firm held another panel presentation entitled, "Identifying and Overcoming Stereotypes and Racial and Economic Prejudice in Housing". Panelists discussed the roots and manifestations of prejudice, exclusion, inequality and segregation in housing including how state laws, regulations and government programs have perpetuated segregation in housing, how the federal government has dealt administratively with prejudice and stereotypes in housing; and emerging issues to consider to promote greater integration in housing. The panel featured: Erin Boggs, Executive Director of Open Communities Alliance; David Lavery, Staff Attorney at the Connecticut Fair Housing Center and Anika Singh Lemar, Clinical Associate Professor of Law at Yale Law School. Partner Tim Hollister moderated the panel discussion.

#### Firm Named a Best Law Firm for Female Attorneys

In July, Law360 selected Shipman & Goodwin as one of the Best Law Firms for Female Attorneys. The firm was ranked # 5 among law firms with 150-299 lawyers. The rankings were included in Law360's annual Glass Ceiling Report and were based on above-average representation of women at the partner and nonpartner levels. The firm first debuted in the Law360 ranking at #6 for Best Law Firms for Female Attorneys back in 2010, and has appeared in the top 25 for female partners nationally in years subsequent, until its most recent move up to #5 for 2017. The firm was also ranked # 231 in the Law360 400, which compares the 400 largest U.S.-based law firms.



The school opened in 1997. Dr. Viswanathan designed the school's curriculum and served as dean of faculty. King Abdullah II personally awarded Dr. Viswanathan the King Hussein Medal, Jordan's highest honor, for her endeavors. Following an engaging and inspirational discussion, Dr. Viswanathan answered a number of guestions from the audience.

## Hispanic Heritage Month Celebrated on October 11: "Shaping the Bright Future of America"
