Barry Hawkins practices in the areas of real estate and litigation. He is the author of numerous papers on real estate issues and has taught and lectured extensively on real estate, land use and environmental issues, including alternative dispute resolution.

Barry is a former member of the Board of Governors of the American Bar Association. Since 1983, he has been active in the American College of Real Estate Lawyers and served three years on its national Board and as chair of its Alternative Dispute Resolution Committee. He is the Past President of the Connecticut Bar Association. In addition, Barry is currently the Co-chairman of the national Joint Editorial Board Uniform Real Property Acts (JEBURPA). He has been a member of the national Uniform Law Commission (ULC) since 1997, serving as both a Division Chair and as a member of its Executive Committee through 2019. He is currently co-chairing the ULC Drafting Committee for Elimination of Racially Restrictive Covenants and is serving as a member of the Investment Committee for the Uniform Law Foundation.

He currently serves as Connecticut State Chairman of the Fellows of the American Bar Foundation (ABF) and serves as a member of the Governance Committee of the ABF. He served in the ABA House of Delegates from 2013 -2020 as a Connecticut Delegate, a Member of the ABA Board from 2015-2017 and twice elected as a Delegate At large. He served on the ABA Pension Administration Committee from 2017-2020 and various standing committees of the ABA. He is former Chair of the national drafting committee for the Uniform Prudent Management of Institutional Funds Act (UPMIFA) and Chair of the National Enactment Committee. He lectures nationally on the subject of institutional endowment funds and UPMIFA.

After graduating from the University of Virginia School of Law, Barry served as a Captain in the United States Army. He earned a Bronze Star in Vietnam (1969-1970).
